1. OBJECTIVE:-

Purvanchal Vidyut Vitaran Nigam Ltd. intends to empanel eligible firms for conducting Special Audit of Bill Revision cases, for the financial year 2022-23 and first two quarter of F.Y. 2023-24 (April 2023 to September 2023). - (3) The Firm should have its head office/branch office situated in Discoms Jurisdiction.
- (4) Firms having DISA/CISA/DISSA qualified member will be preferred.

- 2- If the empanelled firms of Chartered Accountants/Cost Accountants do not undertake the Special Audit work or complete the Special Audit work within the prescribed time limit, the management may assign the work to other firms and the loss of work shall be considered for penalty to original allottee firm and the name of that particular firm will be removed from the list of empanelment and extra expenses incurred by the management in getting the work done shall be levied on the original allottee firm to whom the work was previously assigned.
- 3- The management of Discom will have full rights to oust any of the firms from empanelment without assigning any reason and also to change the circles & divisions allotted for Special Audit Work of empanelled firms.
