5.2. The Firm will conduct the Cooperative audit for the period from 2020-2021,2021-2022,2022-2023,2024-2025 as per the scope defined here in and certify it is as per the Statutory Regulations applicable to Co -Operative Societies.

5.3. Other scope of Co -Operative Audit includes 100% verification of major transactions and sampling verification of certain area of the Union, on daily basis. Some of the transactions (not exhaustive/all inclusive) are indicated below:

- a) Design, Standardisation, implementation and monitoring of accounting system and practices to ensure compliance with the accepted system of accounting of our Coop Audit authorities.
- b) Preparation of Day Book finalisation of accounts on monthly, quarterly and yearly basis and timely preparation of financial statements and financial performance indicators in accordance with applicable standards issued from time to time.
- c) Building and strengthening of Internal control & auditing system and various conducting periodical reconciliation procedures.
- d) Preparation of Annual Budgets estimates and Budget execution .
- e) Preparation of Monthly Profit and Loss Account and Annual Trading, Profit & Loss account and Balance Sheet and all reports which required for Final Audit Memorandum.
- f) Scrutinising and verification of all kinds of Bills and supporting vouchers for Payment. Scrutinising all Financial commitment file for payment.
- g) Verification of Bank Reconciliation statements on periodical basis.
- h) Reconciliation of inter-union and Federation transactions .
