5. Terms of Payment: Bill should be submitted by the agency on a monthly basis and payment will be made after due verification of the same and recommendation from concerned officer.



9. The chartered accountant firm is required for service at state office as per scope of work mentioned in this tender document.
10. Earnest Money can be forfeited in case of non-completion/part completion/delayed completion of services unless permitted in writing by Bihar Mahadalit Vikas Mission Society.
