1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The CA firms should have minimum 3 (three) years experience in auditing private/government sector programmes/schemes and tax audit under Section 44AB of Income Tax Act, 1961 with sufficient staff to carry out the task.

2. The CA firms having prior experience of auditing accounts of mission in other departments will be given weightage.

TOR for Statutory Audit

1. Preparation of audited statements (consolidated/audit reports (consolidated) at SPD Level for release of funds to universities and colleges as infrastructure grants and various components.

(Guidelines to be collected from the office of the RUSA, Assam).

2. Preparation of audited statements (consolidated / audit reports (consolidated) at SPD level for fund of Preparatory grant and MMER separately.

3. Preparation of audited statements (consolidated/ audit reports (consolidated) at University level (Guwahati University and Dibrugarh University) for components infrastructure Grants released to Universities and PM-USHA schemes.

4. Preparation of audited statement (consolidated/ audit reports (consolidated) at Collage level for components infrastructure grants to colleges etc.

5. Verification of maintenance of documents\ photographs\asset register\ stock register\ cash books\NIT\NIQ\ estimate\ technical sanction\bank A/c statements\ interest accrued etc. as per RUSA guidelines and reporting of the same in audit reports.

6. Verification of Compliance of Component guidelines while planning/ execution/ supervision of the programmers and reporting of the same in audit reports.

7. Reconciliation of bank account with books of accounts maintained at institutional level.

8. Reconciliation of the component wise receipts/ expenditure.

9. Verification of fund flow mechanism and time required for transfer of fund to vendors and Government accounts.

10. Identification of wrong classification of accounting entries (error of commission / omission) and get the correct entries passed before closure of audit.
 11. Verification of release of central share and matching State Share as per programme guidelines.
 12. Identification of outstanding advances and mention of the same in audit reports (along with the names against which advances are outstanding and since when).
 13. Analysis of the cash balances/ Bank balances/ Advances at the beginning and at the closure of the financial year.
 14. As cash draws from accounts (RUSA a/c) are not permissible, identification of all cash draws and listing of the same in the audit separately.
 15. A separate statement for receipt and expenditure against grant received has to be prepared grant wise clearly indicating sanction no & date.
 16. Preparation of annual statement as per C&AG formats for each component and each institution under audit.
 16. Audit has to be carried out in the SPD office and respective beneficiary institutions and no other place than the respective institution. No hospitality is to be taken by the auditor from the respective institution. Audits are to be carried out parallel in the institution by deploying adequate number of auditing staff and supervisor has to be deployed to co-ordinate with Mission Director, RUSA (Assam).
 17. Discussion of audit report at the end of the Audit with the head of the beneficiary institution dealing with RUSA fund and enclose a certificate to this effect in the audit report duly signed by the Auditor and person concerned with whom discussion are held.
 18. Audit reports to be submitted in triplicate to respective office within two (2) months from the date of engagement.
 19. Any other accounting/audit work entrusted by mission Director, RUSA (Assam) as per exigencies during audit on mutually agreed terms and conditions.
 20. For any clarification the office of the undersigned may be contacted during office hours.
- [Note: Audited statements will include receipts and expenditure statement/balances sheet/Fund-flow Statement and any other statement prescribed by GOI/GoA/CAG.]

3. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in

accordance with the laws.
