

**GENERAL INSTRUCTION, TERMS AND CONDITIONS**

**1 DEFINITIONS**

1.1. The CONTRACT means the documents forming the tender and acceptance thereof and the formal agreement executed between SSC and the CONTRACTOR together with the documents referred to therein including TENDER NOTICE, GENERAL INSTRUCTIONS, SPECIAL TERMS & CONDITIONS, CONDITIONS OF CONTRACT, ADDITIONAL CONDITIONS, TENDER SCHEDULE, instructions issued from time to time by the Competent Authority and all these documents taken together shall be deemed to form one contract and shall be complimentary to one another.

1.2. In the CONTRACT, the following expressions shall unless, where the context otherwise required, have the meaning hereby respectively assigned to them:

The "SSC" means the Staff Selection Commission, and its successors.

The "COMPETENT AUTHORITY" means the Regional Director (Central region) SSC, PRAYAGRAJ-211001.

1.4. Parties: - The parties to the Contract are the contractor (the tenderer to whom the work has been awarded) and the Staff Selection Commission (Central Region), Prayagraj.

1.5. Addresses: For all purposes of the contract including arbitration there under, the address of the contractor mentioned in the tender shall be final unless the contractor notifies a change of address and contact number(s) by a separate letter sent by registered post with acknowledgement due to the SSC, Central Regional Office, Prayagraj. The contractor shall be solely responsible for the consequences of any omission or error to notify change of address and contact number(s) in the aforesaid manner.

2. The tenderer must read carefully all the terms, conditions and specifications before filling up the tender schedule and his quotation/Bid.
3. In respect of the matters pertaining to this contract, tenderer shall not directly or indirectly bring or attempt to bring any political or outside influences or intervention through any association, union or organization.
