If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting

documents to prove his eligibility for Relaxation.

2. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.

3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

5. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer ,is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid.All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM.If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

- Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
- Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
- Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
- Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- Publishing bids on GeM for procurement of works.

If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

Scope of Work

(Preparation of Annual Accounts Statement for the FY 2025-26)

The selected Chartered Accountant Firm shall undertake the following activities for the Institute:

1. Accounting and Book Finalization

Compilation, scrutiny, and verification of accounting records comprising approximately 20,000 vouchers/transactions for the financial year.

Verification of cash book, bank book, ledgers, and subsidiary registers.

Reconciliation of all ledger balances.

Rectification of accounting errors, if any, in consultation with the Institute.

2. Bank and Ledger Reconciliation

Preparation and verification of Bank Reconciliation Statements (BRS) for all bank accounts.

Reconciliation of advances, deposits, receivables, and payables.

Verification of inter-departmental and inter-fund transactions, if any.

3. Statutory Compliance and Review

Review of compliance with applicable financial rules, accounting standards, and statutory provisions.

Verification of TDS, GST, EPF, ESI, and other statutory deductions and filings (wherever applicable).

Identification and reporting of discrepancies or non-compliance.

4. Preparation of Annual Accounts

Preparation of Annual Accounts in the format prescribed by the Ministry of Education (MoE), Government of India (formerly Ministry of Human Resource Development).

Preparation of:

Balance Sheet

Income & Expenditure Account

Receipts & Payments Account

Preparation of Schedules, Notes to Accounts, and supporting statements as per prescribed formats.

Apart from accounts of the Institute, GPF accounts are also to be prepared.

5. Reporting and Documentation

Submission of finalized accounts along with all supporting schedules and reconciliations.

Preparation of management reports highlighting key observations, discrepancies, and recommendations for improvement.

6. Timeline and Deliverables

The preparation and finalization of the Annual Accounts shall be completed on or before 15.06.2026, to enabling further submission to the competent authority and the C&AG.

The firm shall ensure readiness of all records, schedules, and supporting documents for audit.

Periodic progress updates shall be submitted to the Institute to ensure adherence to the timeline.

7. Other Points:

- a) The firm should have atleast one fully functional office in the state of Kerala or in the Mahe district of the Union territory of Puducherry.
- b) All supporting documents are made available at NIT Calicut, Kozhikode - 673601, Kerala.
- c) There are around 9,715 payment vouchers, 235 contra vouchers, 2,100 journal vouchers and 1,660 receipt vouchers, during F.Y 2025-26. The figures are provisional and may increase upon reconciliation,adjustment/closing entries etc.
- d) The contract value shall include all taxes and levies as applicable. Any change in the tax structure at a later date within the contract duration may be considered.
- f) The firm shall make all arrangements for food, travel, accomodation and other expenses for its employees/ staff/representatives.

Eligibility Criteria for Chartered Accountant Firms

The Chartered Accountant Firm must meet the following criteria:

The firm should be registered with the Institute of Chartered Accountants of India (ICAI).

Minimum 5 years of experience in preparation/finalization/audit of accounts of Government Institutions/Autonomous Bodies/Educational Institutions.

The firm should have adequate manpower, including at least one qualified Chartered Accountant as partner.

Experience in handling high-volume transactions (preferably above 10,000 vouchers annually).

The firm should not have been blacklisted by any Government Department/Agency.

The firm should have valid PAN, GST registration, and other statutory registrations.
