Proper bill/invoice (two sets) including GeM Bill, Sellers's tax invoice and other supporting documents must be provided by the service provider every month for bill settlement. So that, payment of the bill can be released after confirmation of details.

11. In case of contract breach, the contract can be terminated by giving one month (30 days) clear notice binding on both the parties.

Note: - None of the committee members has any personal relations / interests with the firms/agencies participating in the tender process.
