3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

**1. Introduction**

Employees' Provident Fund Organisation (EPFO), Regional Office, Raipur, proposes to empanel Chartered Accountant Firms for a period of **three (03) years** for handling taxation matters, accounting-related advisory work, special audit, reconciliation of financial entries, compliance matters, scrutiny of records, Government Accounting, certification work, forensic/accounting examination (if required), and other allied financial/accounting assignments as may be assigned from time to time.
